

2007-2008 TENNESSEE PRE-KINDERGARTEN FACT SHEET

Governor Bredesen and the General Assembly allocated an additional 25 million in the FY 08 state budget for the expansion of Pre-K education. This appropriation resulted in the following:

- 257 new Pre-K classrooms opened the fall of 2007
- 9 additional school systems provided state-supported pre-k education for the first time in their school districts in the fall of 2007
- TN state-supported Pre-K programs are located in:

94 of 95 TN Counties
133 of 136 TN School Systems

- The 148 Pilot pre-k classrooms received funding at the same level as the Voluntary Pre-K classrooms due to recent legislation.
- Governor Bredesen, with the support of the TN General Assembly, has provided 70 million new dollars for Pre-K education over the past three years to open an additional 786 new classrooms across Tennessee.

The existing Pilot program is still funded with 10 million in state revenue, bringing the total number of Pre-K classrooms to 934 and funding to 80 million for 2007-2008.

***Head Start enrolls approximately 12,000 4 year olds. However, LEAs and Head Start are partnering to serve approximately 3,000 of these at-risk students in collaborative classrooms. These students are included in the above State Pre-K data.*

Opening 300 new pre-k classes next year would serve about 5,000 (6%) more 4 year olds.
